was launched in 2009 to respond to these cases with an unprecedented level of collaboration and coordination.

This is a new partnership of NYC's government and non-profit agencies, many of which have been addressing the problem of elder abuse for decades. Now, through NYCEAC, these organizations provide a streamlined and rapid response to elder abuse cases. In addition, the depth and breadth of expertise and resources of the participating agencies helps to minimize gaps and reduce systems fragmentation and overlap of services.

## Multidisciplinary Teams

The NYCEAC coordinates and facilitates two teams. The Manhattan-based team is called the Elder Abuse Case Coordination and Review Team (EACCRT); the Brooklyn-based team is called the Brooklyn MDT.

Although the two teams are designed differently, both offer a central response point for the agencies and people working on elder abuse cases in the community. In addition, both MDTs serve as an important informational resource for professionals working in the health, mental health, public safety, justice/legal, victim assistance and social service systems.

Professionals throughout Brooklyn and Manhattan have an opportunity to present complex elder abuse cases to the MDTs and receive recommendations on assessment and interventions from the teams.
